

## Official Rules

### Denison Days of Summer Sweepstakes (the “Sweepstakes”)

**NO ENTRY FEE, OTHER PURCHASE, OR DONATION NECESSARY TO ENTER OR WIN. A DONATION WILL NOT INCREASE YOUR CHANCES OF WINNING**

**Eligibility.** The Sweepstakes is open to Denison alumni who are legal residents of the 50 United States and District of Columbia, who are at least 18 years old at time of entry. Sponsor and its respective affiliates, subsidiaries, successors, assigns, agents, representatives, officers, directors, shareholders, and employees, and any entity involved in the development, production, implementation, administration, judging or fulfillment of the Sweepstakes, including without limitation, the immediate family members of such individuals, are not eligible to participate. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Sponsor reserves the right to disqualify any person that violates these rules or tampers with or abuses any aspect of this Sweepstakes as solely determined by Sponsor. All decisions made by Sponsor in connection with the Sweepstakes, including without limitation, decisions related to eligibility requirements, are final and binding.

**Sponsor.** The Sweepstakes sponsor is Denison University’s Institutional Advancement Office (“Sponsor”), located at 100 West College Street, Granville, OH 43023.

**Entry Period.** This Sweepstakes begins on June 1, 2023 at 12:01 AM ET and ends on June 30, 2023 at 11:59 PM ET (“Entry Period”).

**How to Enter.** During the Entry Period, visit the registration page located on our website: <https://support.denison.edu/days-of-summer-sweepstakes> and follow the instructions to complete at least one of the following:

1. **Express Interest in Volunteering for Denison:** Electronically complete and submit the [“Volunteer Interest” form](#). You will be asked to provide basic contact information, including your name, street address, phone number, and email address, and identify at least one volunteer opportunity you are interested in learning more about. Based on your responses, a staff member of Denison University will contact you to share more about volunteer opportunities, though participating in a volunteer role is not necessary to win the Sweepstakes.
2. **Make a Donation to Denison:** Make a donation of \$5 or more to Denison online at <https://support.denison.edu/days-of-summer-sweepstakes>. You will be asked to provide basic contact information, including your name, street address, phone number, and email address, and submit payment information. A donation should be an amount of your choosing, and has no impact on your chances of winning the Sweepstakes.

You may also enter the Sweepstakes by mail. To enter the Sweepstakes by mail, type or hand print your first and last name, street address, city, state, zip code, daytime telephone number and email address, along with an explanation of your interest in volunteering for Denison (if applicable), and mail your completed letter to: Denison University’s Institutional Advancement: Attn: Denison Days of Summer Sweepstakes, 100 West College Street, Granville, OH 43023, a “Mail-in Entry”. ALL MAIL-IN ENTRIES MUST BE POSTMARKED NO LATER THAN JUNE 30, 2023 AND RECEIVED BEFORE JULY 7, 2023. Proof of mailing a Mail-in Entry is not considered proof of delivery or receipt. Sponsor is not responsible for any lost or misdirected Mail-in Entries. Illegible or incomplete Mail-in Entries and mechanically reproduced Mail-in Entries will be disqualified. Moreover, false, fraudulent or deceptive Mail-in Entries or acts shall render Mail-in Entry participants ineligible.

**Limitations on Entries.** Limit one entry per person per email address. Any person who attempts or otherwise encourages the entry of multiple or false contact information under multiple identities or uses any device or artifice to enter or encourage multiple or false entries, as determined by Sponsor, will be disqualified. Use of robotic entry devices is strictly prohibited.

**Prizes.** Three (3) Prizes will be awarded, which consists of: 1) **Two-night hotel stay at the Granville Inn** in Granville, Ohio. Winner agrees to accept the Grand Prize “as is” and, by entering, entrants acknowledge that reservation will be made for the first available date that entrant is interested in. Approximate retail value of the Grand Prize is \$500. Any difference between stated approximate retail value and actual value of Grand Prize will not be awarded. Winner is solely responsible for any federal, state, and local taxes. An unclaimed and/or unused Prize will remain the property of Denison or its designee. 2) **Free Reunion registration** for winner’s next scheduled Reunion (determined by winner’s Denison University class year). Approximate retail value of the Reunion registration prize is \$275. Any difference between stated approximate retail value and actual value of Grand Prize will not be awarded. Winner is solely responsible for any federal, state, and local taxes. An unclaimed and/or unused Prize will remain the property of Denison or its designee. 3) One (1) \$100 gift card to the Denison University bookstore. Winner is solely responsible for any federal, state, and local taxes. An unclaimed and/or unused Prize will remain the property of Denison or its designee.

**Drawing.** Winners will be selected in a random drawing from among all eligible entries collected during the Entry Period taking place on or about July 17, 2023 at Sponsor’s principal place of business. The drawing will be conducted by Sponsor, whose decisions and interpretations on all matters relating to the drawing and these rules are final and binding in all respects. Sponsor reserves the right to disqualify any entrant or winner and may refuse to award a prize to a person who is not eligible, has violated a rule, or obtained entry or advantage using fraudulent means. If there is a dispute about the identity of an entrant, prize will be awarded to the natural person to whom the email address is assigned by the internet service provider responsible for the domain associated with the submitted email address. If a winner is found to be ineligible or not in compliance with these rules, winner will be disqualified and an alternate winner may be awarded the prize in a random drawing at Sponsor’s discretion. Winner will be notified by telephone or email. Inability of Sponsor to contact winner by telephone or email within seventy two (72) hours after selection may result in disqualification of winner and an alternate winner may be selected in a random drawing at Sponsor’s discretion. Prize will be sent to winner by U.S. mail within fourteen (14) days after winner has been notified and has accepted the prize. If prize is returned as undeliverable, then prize will be forfeited and another winner may be selected in a random drawing at Sponsor’s discretion.

**Odds.** The odds of winning the Prize will depend on the number of eligible entries received.

**General Terms.** By entering this Sweepstakes, you promise to abide by these Official Rules and decisions of Sponsor, which will be final and binding in all respects. Sponsor reserves the right, at its sole discretion, to refuse, disqualify or withdraw any entry at any time. Sponsor will not be responsible for any injury, damage or loss of any kind arising out of your participation in the Sweepstakes. YOU AGREE TO RELEASE, DISCHARGE, AND HOLD HARMLESS SPONSOR, ITS PARENTS, SUBSIDIARIES AND AFFILIATES, AND THEIR RESPECTIVE EMPLOYEES, OFFICERS, DIRECTORS, REPRESENTATIVES, AGENTS AND ASSIGNS FROM AND AGAINST ANY OR ALL LIABILITY, CLAIMS, LOSSES, INJURIES, OR DAMAGES OF ANY KIND ARISING OUT OF OR IN CONNECTION THE SWEEPSTAKES OR DELIVERY, OR MISDELIVER, ACCEPTANCE USE OF OR INABILITY TO USE THE PRIZE (including, without limitation, claims, costs, injuries, losses of property, rights of publicity or privacy, defamation or portrayal in a false light, whether intentional or unintentional), whether under a theory of contract, tort (including negligence and/or fraud), warranty or other theory. You waive the right to claim any attorney’s fees and any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages. Except where prohibited by law, by accepting prize, winner grants Sponsor a perpetual, worldwide, royalty-free license to use winner’s name, photograph, voice, and/or likeness without further authorization, compensation, or remuneration of any kind for advertising, promotion and other publicity purposes related to the Sweepstakes and/or Sponsor’s data update effort.
